**Take Notice** that the Council of the Corporation of the Municipality of Shuniah will hold a public meeting on **September 24, 2024 at 3:00 pm** to consider a proposed zoning by-law amendment under section 34 of the Planning Act. The purpose and effect of this proposed amendment is to amend Zoning By-law No. 2038-00 to allow for the following:

- An accessory structure to include a second storey.
- which would allow for the construction of a new garage with a second storey.
- The proposed zoning amendment applies only to the subject property and does not affect any other property;

as it relates to the property described as Plan 834 Lot 2 and Part Road Allowance; RP 55R10680 Part 1 known as 2855 Eldorado Beach Road in the Township of MacGregor, Municipality of Shuniah.

Written submissions received after this time will be provided to council by hard copy. Please include your contact information. Please note, comments are made available to the public, and are available on the municipal website.

If you are unable to make written submissions and therefore wish to make an oral statement during the meeting please email the Municipal Clerk at <u>clerk@shuniah.org</u> by noon on Tuesday, September 17<sup>th</sup>, 2024 (one week prior to public meeting) to register. You will be provided further instructions on how you will connect during the virtual meeting.

If you wish to be notified of the decision of the Municipality of Shuniah on the proposed zoning by-law amendment, you must make a written request to the Clerk at the address listed below.

If a person or public body would otherwise have an ability to appeal the decision of the Municipality of Shuniah to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to Municipality of Shuniah before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to Municipality of Shuniah before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.


